

Register for Universal Infant Free School Meals

All children in Reception, Year 1 and Year 2 are offered a school meal at no cost to the parent or carer regardless of benefits. However, if your child is in Reception, Year 1 or Year 2 and you receive one of the qualifying benefits listed below, your child's school will receive extra funding.

Quality food, every day

School meals in Enfield are healthy, tasty, social and fun and choosing a school lunch for your child will help save you up to £500 per year if you take up the offer. In Enfield this has proved popular with parents and children alike.

Can my child still bring a packed lunch?

Yes, they can but we would encourage them to try a school lunch. This will give them a varied and balanced diet and save you time and money. NB. A cash alternative is not available for those pupils not taking a school lunch.

Families who receive certain benefits may be eligible for free school meals, under one of the following categories:-

Expanded Free School Meals.

- All children in households receiving Universal Credit will be entitled to Free School Meals, regardless of income.

Targeted Free School Meals

- Universal Credit with an annual net earned income of **no more than £7,400 (£616.67 per month)**
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part 6 of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
- Child Tax Credit only (**with no Working Tax Credit**) with an annual gross income of no more than £16,190. **Working Tax Credit is a disqualifying benefit regardless of your household income – this means that you would not be entitled to free school meals whilst in receipt of Working Tax Credit**
- Working Tax Credit run-on (paid for the four weeks after you stop qualifying for Working Tax Credit)

Families who qualify for Targeted Free School Meals will also receive Holiday activity and Food Program vouchers (HAF vouchers).


Pupil Premium - extra funding for your child's school

Schools can claim additional funding from central government, known as the 'Pupil Premium' for those children who are eligible for Targeted Free School Meals. This additional money is used to ensure that children achieve academically and have full access to educational and cultural activities. However, it is for the school to decide how the money is spent. For more information, please ask at your child's school.
